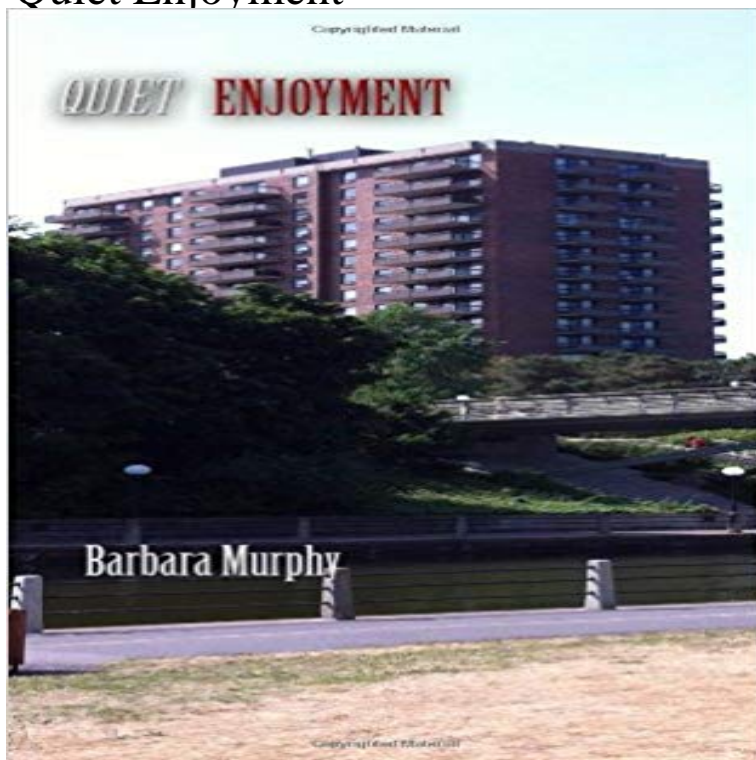


## Quiet Enjoyment
